RESOLUTION RECLASSIFYING LOTS NOS. 1704-PSC-49 & 1705 – PSC-49, T-11-382 WITH AN AREA OF TWENTY THREE THOUSAND FIVE HUNDRED NINETY FOUR (23,594) SQUARE METERS MORE OR LESS AND LOCATED AT BARANGAY 7 POBLACION, TIGBAUAN, ILOILO FROM AGRICULTURAL TO PARK OR OPEN SPACE (CEMETERY) AND ENDORSING THE APPLICATION FOR CONVERSION OF SAID LOTS TO THE REGIONAL OFFICE OF THE DEPARTMENT OF AGRARIAN REFORM (DAR), ILOILO CITY

WHEREAS, the reclassification is within the existing approved zoning ordinance of the comprehensive land use plan;

WHEREAS, the property is within the functional zones where specific land use is allowed;

WHEREAS, the property will be economically feasible to the development of the municipality;

NOW, THEREFORE, on motion of Hon. Richard Tenerife, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Cornelia Teruel,

RESOLVED, to Reclassify Lot Nos. 1704-PSC-49 & 1705 – PSC-49, T-11-382 with an area of twenty Thousand Five Hundred Ninety Four (23,594) square meters more or less and located at Barangay 7, Poblacion, Tigbauan, Iloilo from Agricultural to Park or Open Space (Cemetery) and endorsing the application for conversion of said lots to the Regional Office of the Department of Agrarian Reform (DAR, Iloilo City,
