RESOLUTION APPROVING AND LEGITIMIZING THE THREE (3) YEAR SUB-PROJECT PROPOSAL FOR EARLY CHILDHOOD DEVELOPMENT IN THE MUNICIPALITY OF TIGBAUAN WITH THE TOTAL INVESTMENT IN THE AMOUNT OF EIGHTY THREE MILLION EIGHT HUNDRED EIGHTY EIGHT THOUSAND FIVE HUNDRED FIFTY SEVEN PESOS AND 50/100 (83,888,557.50) AND WITH A TOTAL MUNICIPAL EQUITY IN THE AMOUNT OF FOUR MILLION ONE HUNDRED TWENTY ONE THOUSAND SEVEN HUNDRED TWENTY EIGHT PESOS & 70/100 (4,121,728.70)

WHEREAS, the Municipality of Tigbauan has been chosen one of the beneficiaries of the Early Childhood Development (ECD) Program in the Province of Iloilo;

WHEREAS, the Early Childhood Development (ECD) project is designed to build and improve the existing health, nutrition and early education services for young children and parents;

WHEREAS, it seeks to promote the children's right to survive, to develop their optimum potential and ensure their protection from abuse and neglect by educating their parents and care givers, thus demonstrating a positive impact on the overall development of young Filipino children most especially from the poor and the disadvantaged communities;

WHEREAS, there is a need to expand and improve the health, nutrition, care and early education program of our children as we compare them with other ASEAN member countries, the indicator for the survival and development of the Filipino children such as in terms of infant and child mortality, malnutrition and psychosocial development etc.;

NOW, THEREFORE, on motion of Hon. Rexfel Trivilegio, Chairman, Committee on Senior Citizens and duly seconded by Hon. Richard Tenerife, Hon. Cecilia Garrido and Hon. George Tribunal,

RESOLVED, to approve and legitimize the three (3) year sub-project proposal for Early Childhood Development in the Municipality of Tigbauan with the total investment in the amount of Eighty Three Million Eight Hundred Eighty Eight Thousand Five Hundred Fifty Seven Pesos & 50/100 (P83,888,557.50) and with a total municipal equity in the amount of or Million One Hundred Twenty One Thousand Seven Hundred Twenty Eight Pesos & 70/100 (P4,121,728.70),

RESOLVED FURHTER, to furnish copies of this Resolution to the Office of the Regional Director, to the DSWD, Region VI, Iloilo City, to Hon. Mayor Myrna M. Torres and other concerned government agencies and instrumentalities.
