RESOLUTION 2000-040

RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE HONORABLE SENATOR ANNA DOMINIQUE "NIKKI" COSETENG IN THE AMOUNT OF THREE MILLION PESOS (P3,000,000.00) FOR THE CONSTRUCTION OF LYING-IN CLINIC, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Annex Building of the Rural Health Unit was temporarily used in 1996 as lying-in clinic during the prevalence of dengue fever, this municipality, to serve the affected patients;

WHEREAS, because there were only small rooms constructed, said Annex Building cannot accommodate the volume of patients admitted in said lying-in clinic;

WHEREAS, there is a need to expand the building to accommodate the volume of patients specially coming from the different fifty two (52) barangays of Tigbauan, Iloilo;

WHEREAS, due to financial constraint this building can not be realized without the assistance from the national government specially from Senator Anna Dominique "Nikki" Coseteng;

NOW THEREFORE, on motion of Hon. Cecilia Garrido, Chairman, Committee on Health and Environmental Sanitation and duly seconded by Hon. Ma. Bernardita Taasan and Hon. George Tribunal,

RESOLVE AS IT IS HEREBY RESOLVED, to request financial assistance from the Honorable Senator Anna Dominique "Nikki" Coseteng in the amount of Three Million Pesos (P3,000,000.00) for the construction of lying-in clinic, Municipality of Tigbauan, Province of Iloilo.

RESOLVE FURTHER, to furnish copies of this resolution to the Hon. Senator Anna Dominique "Nikki" Coseteng for her information and favorable action, and to Hon. Mayor Myrna M. Torres for her information and guidance.
