RESOLUTION REQUESTING HON. ALFREDO LIM, SECRETARY, DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) TO DONATE ONE (1) UNIT FIRE TRUCK FOR THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF LOILO

WHEREAS, the Municipality of Tigbauan has a distance of about 23 kms. away from the Fire Departments in Iloilo City;

WHEREAS, based on the previous fire incidents that happened in Tigbauan, when the fire trucks reached the scene of the fire, the buildings were already razed by fire;

WHEREAS, because of this experience, we have in mind to ask this assistance from Hon. Alfredo Lim to donate one (1) unit fire truck for the Municipality of Tigbauan;

WHEREAS, if only this municipality has its own fire truck, theses unforeseen events could be prevented or the spread of fire could at least be minimized as early as possible;

NOW, THEREFORE, on motion of Hon. George Tribunal, Chairman, Committee on Peace and Order and Public Safety and was unanimously seconded,

RESOLVED, to request Hon. Alfredo Lim, Secretary, Department of Interior and Local Government (DILG) to donate one (1) unit fire truck for the Municipality of Tigbauan, province of Iloilo,

RESOLVED FURTHER, to forward copies of this resolution to Hon. Alfredo Lim for his information and favorable action and to Hon. Mayor Myrna M. Torres for her information and guidance.
