RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE HON. EDUARDO PILAPIL VFP – PARTY LIST REPRESENTATIVE, IN THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) FOR THE CONSTRUCTION OF WAR VETERANS AND SENIOR CITIZENS BUILDING IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, on his official visit in the Municipality of Tigbauan last march 18, 2000 during the celebration of the Liberation of Panay and Romblon, Congressman and VFP – Party List Representative, Hon. Eduardo Pilapil had promised to give a financial assistance in the amount of one million pesos (P1,000,000.00) for the construction of the veterans and Senior Citizens Building in said municipality;
