RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE HONORABLE VICE PRESIDENT, REPUBLIC OF THE PHILIPPINES, GLORIA MACAPAGAL-ARROYO IN THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) FOR THE CONSTRUCTION OF WOMEN AND CHILDREN CENTER IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Tigbauan, Women and Family Council supports the holistic program, of the government encouraging women to take active roles in their family formation towards maintaining sustainable development as stressed in global, international and national conferences;
