RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HON. MIRIAM DEFENSOR-SANTIAGO, SENATOR, REPUBLIC OF THE PHILIPPINES IN THE AMOUNT OF TWO MILLION PESOS (P2, 000, 000.00) FOR THE ESTABLISHMENT OF THE TIGBAUAN WATER DISTRICT, MUNICIPALITY OF TIGBAUAN, ILOILO

WHEREAS, the proposed project aims to develop the water system of Tigbauan Water District and will directly benefit 6, 190 population (1,079 service connection) by year 2005;

WHEREAS, the proposed water supply system will cover the nine barangays in the Poblacion and a portion of Barangay Parara Sur;

WHEREAS, the total cost including contingencies and engineering charges amounted to P17.716 million;

NOW, THEREFORE, on motion of Hon. George Tribunal, Chairman, Committee on Peace & Order and Public Safety and unanimously seconded,

RESOLVED, to request financial assistance from the Hon. Miriam Defensor-Santiago, Senator, Republic of the Philippines in the amount of Two Million Pesos (P2, 000,000.00) for the establishment of the Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to furnish copies of this Resolution to the Hon. Senator Miriam Defensor-Santiago for her information and favorable action and to Hon. Mayor Myrna M. Torres for her information and guidance.
