RESOLUTION REALIGNING THE AMONT OF NINETY THOUSAND TWO HUNDRED TWENTY TWO PESOS AND 35/100 (90,222.35) FOR SMALL WATER IMPOUNDIG PROJECTS FROM THE 1999 20% IRA FUND TO THE MAINTENANCE OF FARM TO MARKET ROADS

WHEREAS, due to bad weather condition, most of the farm to market roads in the municipality are in dire need of re-gravelling;

WHEREAS, the funds allocated from the 199 30% IRA Fund for small water impounding projects of the municipality has a remaining amount of P90, 222.35;
