RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. MYRNA M. TORRES, TO ACCEPT AND SIGN IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, ALL DOCUMENTS PERTINENT TO THE DONATION OF THE USED GARBAGE COMPACTOR TRUCK

WHEREAS, garbage disposal is one of the problems of residents, most specially in the different barangays within the poblacion, considering that there is no available truck for garbage collection and disposal;

WHEREAS, the local government unit of Tigbauan, Iloilo could not purchase garbage compactor truck due to financial constraints;

WHEREAS, Mr. Hiroyuki Tsuchiya of RH International Co., Ltd. of Kawagawa-ken, Japan is offering to donate a Garbage Compactor Truck, provided that the recipient thereof will shoulder the transportation, handling and other expenses relative to the donation;
