RESOLUTION CHANGING THE POSITION OF THE ASSISTANT MUNICIPAL HEALTH OFFICER TO MEDICAL OFFICER V, BOTH HAVING THE SAME SALARY GRADE LEVEL OF 22

WHEREAS, it was observed that some positions indicated in the Qualification Standards (QS) as contained in CSC M.C. No. 46, s. 1993 were no longer listed in the Index of occupational Services (IOS), thus the basis for personnel selection both for the CSC Field Offices and Government Agencies, local and national;

WHEREAS, pursuant to CSC Resolution No. 97-0404, there is a need to update and fine-tune polices pertinent to Qualification Standards considering the various developments in the scope of personnel actions and in line with the thrust of professionalizing the Civil Service;

NOW, THEREFORE, on motion of Hon. Cecilia Garrido, Chairman, Committee on Health and Sanitation and duly seconded by Hon. Rexfel G. Trivilegio and Hon. Rene Ledesma,
