RESOLUTION AUTHORIZING THE HON. MAYOR MYRNA MONTEALEGRE-TORRES TO PUBLISH, DISPLAY AND POST PICTURES INCLUDING THE NAMES OF PERSONS APPRHENDED FOR DRUG PUSHING, DRUG USING ND CRIMINAL CHARGES AGAINST HEIOUS CRIMES BY THE LOCAL POLICE AUTHORITIES

WHEREAS, drug related crimes have increased considerably and become uncontrollable that the publi live every minute of their lives covering for fear;

WHEREAS, the government seems at a loss as to how this menace of society could be stricken out in our midst;

WHEREAS, cases of murder, rape, robbery and other heinous crimes are all attributed to drug addiction which destroy the very care of our society and to which young people who are considered the future leaders of our nation caught in the web of self-destruction;

WHEREAS, in order to arrest this growing problem against all forms of criminality more particularly on drug using, iron fists are needed to offset the powers of drug which little by little are killing the economic stability of our society;

NOW, THEREFORE, on motion of Hon. George Tribunal, Chairman, Committee on Peace and Order and Public Safety and duly seconded by Hon. Cornelia Teruel and Hon. Jonathan Torrato,

RESOLVE, AS IT IS HEREBY RESOLVED, to authorize the Hon. Mayor Myna Montealegre-Torres to publish, display and post pictures including the names of persons apprehended for drug pushing, drug using and criminal charges against heinous crimes by the Local Police Authorities,

RESOLVED FURTHER, that in line with anti-drug of the national government, the publication and posting of pictures and names of persons apprehended shall be done weekly or bi-monthly so that this will e a continuing project of the Office of the Mayor and the Sangguniang Bayan with the special assistance of the Police Department,

RESOLVED FINALLY, that copies of this resolution shall be forwarded to Municipal Mayor Myrna M. Torres, to the PNP-Tigbauan c/o P/S Insp. Antonio B. Bersmin, to all barangay captains of this municipality c/o the President of the Liga ng mga Barangay and to all concerned government agencies for their information, guidance and appropriate action.
