RESOLUTION PRESERVING THE PLACUNA PLACENTA LOCALLY KOWN AS "LAMPIRONG" IN THE MUNCIPAL WATERS OF TIGBAUAN, ILOILO

WHEREAS, Placuna Placenta, locally known as "Lampirong" had been abundant in the municipal waters of Tigbauan, lloilo for the past years;

WHEREAS, way back in 1987, it had been observed that the harvesting or the taking of placuna placenta from our municipal waters had been abused or was not done properly;

WHEREAS, on September 17, 1999, the LGU-Tigbauan in collaboration with the SEAFDEC, conducted the first seeding of the Placuna Placenta brood Stock in the municipal waters of Tigbauan, particularly at Barangay Namocon;

WHEREAS, the objective of the LGU-Tigbauan together with SEAFDEC is not only to receive the Capiz Shell Industry in this municipality but also to provide better livelihood specially to the marginal fishermen/fisher folks of our coastal Barangays;

WHEREAS, to achieve this objective, the harvesting of placuna placenta for the first year is prohibited to preserve the Placuna Placenta Brood Stock specially during this first year;

WHEREAS, with the preservation of this Placuna Placenta Brood Stock, w may come to realize the importance of Capiz Shell Industry and may help achieve the objective of the LGU-Tigbauan and SEAFDEC for a better life specially to the marginal fisher folks/.fishermen;

WHEREAS, the availability of Placuna Placenta in this municipality will also gear towards sustainable aquaculture and community development towards better environment;

NOW, THEREFORE, on motion of Hon. Richard T. Tenerife, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Rene Ledesma,

RESOLVED, to preserve the Placuna Placet locally known as "lampirong" in the Municipal Waters of Tigbauan, lloilo,

RESOLVED FURTHER, to furnish copies of this Resolution to the Hon. Mayor Myrna M. Torres, for her information and appropriate action, the SEAFDEC, Tigbauan, Iloilo, the coastal barangays of this municipality thru the respective Barangay Captains and to all concerned persons and/or agencies for their information and guidance.
