RESOLUTION REQUESTING THE PENRO, PROVINCE OF ILOILO, TO ISSUE PERMIT AND THE DENR, REGION VI TO ISSUE ENVIRONMENTAL COMPLIANCE CERTIFICATE TO ELIZABETH TANALES TO EXTRACT SAND AND GRAVEL AT THE SIBALOM RIVER WITHIN THE TERRITORIAL JURISDICTION OF BARANGY DORONG-AN, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Art. 100 of the Local Government Code of 1991 (R.A. 7160) empowers the Sangguniang Bayan to pass a resolution for an efficient protection of the environment;

WHEREAS, the Barangay Dorong-an Officials passed a resolution endorsing the said applicant to quarry at their allowed quarry areas to avoid further riverbank destruction;

WHEREAS, the proper extraction of sand and gravel at the Sibalom River will answer to the present riverbank destruction and it will also be the source of an additional income to the community;

NOW, THEREFORE, on motion of Hon. Richard Tenerife, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Rexfel G. Trivilegio,

RESOLVED, to request the PENRO, Province of Iloilo to issue permit and the DENR, Region VI. To issue ECC to Elizabeth Tanales to extract sand and gravel at the Sibalom River within the territorial jurisdiction of Brgy. Dorong-an, Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to forward copies of this resolution to the Governor, Province of Iloilo, the PENRO, and the DENR, Province of Iloilo, to Hon. Mayor Myrna M. Torres and to all concerned for their information and guidance.
