RESOLUTION REQUESTING THE PENRO PROVINCE OF ILOILO, TO ISSUE PERMITS AND THE DENR, REGION VI TO ISSUE ENVIRONMENTAL COMPLIANCE CERTIFICATES TO JOSEPH TUVIDA, MERCEDITA TINASAS AND EDWIN TUVIDA TO EXTRACT SAND AND GRAVEL AT THE SIBALOM RIVER WITHIN THE TERRITORIAL JURISDICTION OF BARANGAY NAPNAPAN NORTE, MUNICIPALITY OF TIGBUAN, PROVINCE OF ILOILO

WHEREAS, Art. 100 of the Local Government Code of 1991 (R.A. 7160) empowers the Sangguniang Bayan to pass a resolution for an efficient protection of the environment;

WHEREAS, the barangay officials concerned pass a resolution of endorsement in their respected barangays, endorsing the said applicants to quarry at their respective allowed quarry areas to avoid further riverbank destruction;

WHEREAS, the proper extraction of sand and gravel at the Sibalom River will answer to the present riverbank destruction and it will also be the source of an additional income to the community;

NOW, THEREFORE, on motion of Hon. Richard Tenerife, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Rexfel G. Trivilegio,

RESOLVED, to request the PENRO, Province of Iloilo to issue permits and the DENR, Region VI, to issue ECC, to Joseph Tuvida, Mercedita Tinasas and Edwin Tuvida to extract sand and gravel within the territorial jurisdiction of Brgy. Napnapan Norte, Municipality of Tigbauan, Province of Iloilo,
