RESOLUTION EARNESTLY REQUESTING FINANCIAL ASSISTANCE FROM HON. EDGARDO ANGAA, SECETARY, DEPRTMENT OF AGRICULTURE IN THE AMOUNT OF TWO MILLION PESOS (P2,000,000.00) FOR THE REPAIR AND REHABILITATION OF THE TIBAUAN PUBLIC MARKET IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Tigbauan Public Market was constructed in 1950 and is now very dilapidated;

WHEREAS, its construction framework including the walls and roofs could hardly withstand the effects of bad weather specially during rainy reason thereby necessitating its immediate repair and rehabilitation;

WHEREAS, because of limited sources of local funds and the lack of repair and maintenance, the market building and facilities are fast deteriorating resulting to the leaking of roofs, torn or broken walls, defective lighting facilities, drainage system and comfort rooms, inadequate water supply, (etc.);

WHEREAS, if we have a good and presentable public market, we can also have good collection of revenues, but at present, the income derived from our market is just enough to maintain the salaries, wages and other fringe benefits of our market employees;

WHEREAS, the Municipal Government of Tigbauan, much to its desire to undertake the reconstruction of the Tigbauan Public Market, could not possibly make it unless it can have other ources of funds or the required financing;

WHEREAS, the Municipal Government of Tigbauan, much to its desire of giving a better market place to their constituents, pin down their hopes to the good Secretary of the Department of Agriculture for its realization;

NOW, THEREFORE, on motion of Hon. Ma. Bernardita T. Taasan, Chairman, Committee on Rules, Ordinances, Resolutions and Legal matters and was unanimously seconded,

RESOLVED, to request financial assistance from Hon. Edgardo Angara, Secretary, Department of Agriculture in the amount of two million pesos (P2,000,000.00) for the repair and rehabilitation of the Tigbauan Public Market in the Municipality of Tigbauan, Province of Iloilo.
