RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HON. EDGARDO ANGARA, SECRETARY,  
SEPARTMENT OF AGRICULTURE IN THE AMOUNT OF ONE MILLION PESOS, (P1,000,000.00) FOR THE  
REPAIR AND MAINTENANCE OF FARM TO MARKET ROADS IN THE MUNICIPALITY OF TIGBAUAN,  
PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan comprising of 52 barangays and is 23 kms. away from  
the City of Iloilo, is one of the fast developing towns in the Province of Iloilo with vast farmlands suited  
for agriculture and most of its inhabitants are engaged in farming as their means of livelihood;

WHEREAS, residents from the said barangays in this municipality are complaining about the bad  
condition of the farm to market roads which resulted to the difficulty of transporting their farm products  
to the poblacion and other neighboring municipalities due to lack of transportation facilities;

WHEREAS, in order to solve this problem, the rehabilitation, repair and maintenance of the farm to market roads is urgency needed;

WHEREAS, the LGU-Tigbauan can hardly cope up with the finances to e incurred for the repair and maintenance of these farm to market roads which is necessary for the efficient and effective delivery of basic services;

NOW THEREFORE, on motion of Hon. George Tribunal, Chairman, Committee on Infrastructure, Transportation, Communication and Public Utilities and was unanimously seconded,

RESOLVED, to request financial assistance from Hon. Edgardo Angara, Secretary, Department of Agriculture, in the amount of one million pesos (P1,000,000.00) for the repair and maintenance of farm to market roads in the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to forward a copy of this resolution to Secretary Edgardo Angara for his information and favorable action.
