RESOLUTION INDORSING THE HEREIN ATTACHED RESOLUTION NO. 005, S. 2000 OF BRGY. NAGBA,  
TIGBAUAN, ILOILO TO REQUEST THE DEPARTMENT OF AGRICULTURE PHILIPPINE COCONUT AUTHORITY  
FOR THE REHABILITATION OF BRGY. NAGBA ROAD, BRGR. NAGBA, TIGBAUAN, ILOILO

WHEREAS, the Department of Agriculture-Philippine Coconut Authority under Administrator  
Eduardo U. Escueta issued an unnumbered Department Memorandum dated 16 June 2000 to all its  
Regional managers with the subject: SUBMISSION OF PROPOSED LIST OF FARM-TO-MARKET-ROADS  
(either for construction or rehabilitation leading to the Maunlad Model Farms);

WHEREAS, pursuant o said memorandum, the barangay Officials of Brgy. Nagba, Tigbauan, Iloilo  
passed the herein attached Resolution No. 005, S. 2000 and recommended the rehabilitation of its farm-
