RESOLUTION REQUESTING HONORABLE MANUEL VILLAR, SPEAKER, HOUSE OF REPRESENTATIVES, IN  
THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) FOR THE CONSTRUCTION OF SITIO  
TABUC-DANAO FARM TO MARKET ROAD AT BARANGAY BITAS, MUNICIPALITY OF TIGBAUAN, PROVINCE  
OF ILOILO

WHEREAS, the Municipality of Tigbauan, comprising a 52 barangays and is 23 kilometers away  
from the City of Iloilo has vast farmlands suited for agriculture and most of its inhabitant are engaged in  
farming as their means of livelihood;

WHEREAS, residents of Sitio Tabuc-Danao, Barangay Bits, this municipality are complaining  
about the difficulty of transporting their products to the Poblacion due to the absence of farm to  
market road;

WHEREAS, in order to solve this problem, the construction of about 1.2 kilometers Sitio Tabuc-  
Danao farm to markjet road to connect Barangay Bitas road, this municipality is badly needed;

WHEREAS, the Municipal Government of Tigbauan, much to its desire to undertake the needed  
construction of its farm to market roads, could not possibly make it because of financial constraints  
unless it can have other sources of funds;

NOW, THEREFORE, on motion of Hon. Ma. Bernardita T. Taasan, Chairman, Committee on Rules,  
Ordinances, Resolutions and Legal Mattes and duly seconded by Hon. Cecilia Garrido,

RESOLVED, to request Hon. Manuel Villar, Speaker, House of Representatives, in the amount of Five Hundred Thousand Pesos (P500,000.00) for the construction of Sitio Tabuc-Danao farm to market road at Barangay Bitas, Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to furnish copies of this resolution to Hon. Manuel Villar, Speaker, House of Representative for his information and favorable action.
