RESOLUTION EARNESTLY REQUESTING HONORABLE BOARD MEMBER ANITA SILLA IN THE AMOUNT OF
TWENTY-FIVE THOUSAND PESOS (P25,000.00) TO BE USED FOR THE LIVELIHOOD PROJECTS OF THE
WOMEN AND FAMILY COUNCIL, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Tigbauan women Family Council (TIGWOFACO), as created by an ordinance, will
initiate and facilitate the provision of a holistic program encouraging women to take active roles in their
family formation toward maintaining sustainable development;

WHEREAS, the Women's Core Group, composed of all women kagawads of 52 barangays, this
municipality, holds its regular meeting every 2nd Tuesday of the month starting 2:00 o'clock to 5:00
o'clock in the afternoon;

WHEREAS, one of the livelihood projects of the TIGWOFACO is the co-called "KAPWA TANIM
Project" which means, "Kamtin Ang Pag-unlad, Walang Atrasan – Tigbauan Ating Naisin,
Itaguyod/Ipaglaban Magkailan Man"

WHEREAS, "KAPWA – TANIM Project" does not merely refer to the planting of trees, flowers,
vegetables, herbals for market but also to live out, perseverance, patience, industriousness, love and
care for the fellow Tigbauenos by integrating value formation, related trainings and seminars that will
lead families the powerhouse of harmonious relationship among individuals who are empowered,
responsible, peaceful, economically stable, healthy and spiritually guided by Divine Providence;

NOW, THEREFORE, on motion of Hon. Cecilia Garrido, Chairman, Committee on Human Rights,
Women and Family and duly seconded by Hon. Cornliea Teruel;

RESOLVED, to earnestly request financial assistance from Hon. Board Member Anita Silla in the amount of P25,000.00 to be used for the livelihood projects of the Women and Family Council, Municipality of Tigbauan, Province of Iloilo,
