RESOLUTION FAVORABLY ENDORSING THE FORESHORE LEASE APPLICATION OF LOU-BEL DEVELOPMENT
CORDPRATION SITUATED AT BARANGAY NAMOCON, TIGBAUAN, ILOILO

WHEREAS, the Lou-Bel Development Corporation, filed an application for foreshore lease on July
1, 1996 at CENRO, DENR, Iloilo City for an area of P10,800 square meters more or less;

WHEREAS, the foreshore applied for is suitable for the purpose to which it will be devoted
specifically for a beach resort;

WHEREA, the Philippine Ports Authority, Port of Iloilo, thru its Port Manage Christian V.
Santillan, informed (as per 1st Endorsement dated June 17, 1998) to CENRO, DENR, Iloilo City that the
said parcel fo land applied for is not needed by the PPA;

WHEREAS, the DPWH-Iloilo 1st Engineering District, thru Engr. Elmer S. Silveo, OIC- District
Engineer, likewise informed (as per 1st Endorsement dated May 31, 2000 to Mr. Ariel A. Gloria, OIC,
CENRO Officer) that the said parcel of land applied for is currently not needed by the DPWH, Iloilo Ist
Engineering District, provided that the twenty (20) meters easement zone be observed in compliance
with Article 51 of P.D. 1067 otherwise known as the Water Code of the Philippines;

WHEREAS, the people in the barangay are in full support of the project specially that they were
assured of priority in the employment of workers by Lou-Bel Development Corporation during the
improvement of the foreshore area ta Barangay Namocon, Tigbauan, Iloilo;

WHEREAS, the project will boost Tourism and will bring economic benefits to the Municipality in terms of revenues and likewise employment to the local residents;

WHEREAS, at present the Local Government of Tigbauan has no available funds for the improvement of the foreshore area at Brgy. Namocon, Tigbauan, Iloilo;

NOW, THEREFORE, on motion of Hon. Cornelia Teruel, Vice Chairman, Committee on environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Rene Ledesma,

RESOLVED, to favorably endorse the foreshore Lease Application of Lou-Bel Development Corporation, situated at Brgy. Namocon, Tigbauan, Iloilo,
