RESOLUTION ALLOCATING THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00) AS COUNTERPART OF THE MUNICIPALITY FOR THE DPWH-LGU-COST SHARING INFRASTRUCTURE PROJECTS TO BE IMPLEMENTED IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO, CHARGEABLE AGAINST THE 20% MUNICIPAL IRA FUND CY 2000

WHEREAS, the League of Municipalities of the Philippines (LMP) thru its national president, Honorable Mayor Jinggoy E. Estrada had signed a Memorandum of Agreement (MOA) with the Department of Public Works & Highways (DPWH) last March 15, 1999 regarding the DPWH-LGU Cost Sharing Program for the implementation of infrastructure projects and to promote rural development in the municipalities;

WHEREAS, the National Government, through the DBM had released the amount of P1.54 Billion for the purpose of allocating P1 Million for each of the municipalities as its counterpart fund to implement such projects;

WHEREAS, to fully implement the DPWH-LGU Cost Sharing Program, the municipality shall provide funds as counterpart for the infrastructure projects;

WHEREAS, the amount needed by the LGU-Tigbauan, as its counterpart for the implementation of the said projects is P250,000.00 to be charged against the 20% Municipal IRA Fund CY 2000 (under the P650,000.00 – Allocation for the implementation of various infrastructure projects);

WHEREAS, this amount of P250,000.00 shall be transferred to a trust account to be maintained by the municipality for the purpose of implementing the DPWH-LGU cost sharing projects;

NOW, THEREFORE, on motion of Honorable Ma. Bernardita T. Taasan, Chairman, Committee on Appropriation, Budget, Finance and Accounts and duly seconded by Hon. Remedios Torrato,

RESOLVED, to allocate the amount of P250,000.00 as counterpart of the municipality for the DPWH-LGU Cost sharing Infrastructure Projects to be implemented in the Municipality of Tigbauan, Province of Iloilo chargeable against the 20% Municipal IRA Fund CY 2000,

RESOLVED FURTHER, to furnish copies of this resolution to Hon. Jinggoy E. Estrada the DPWH, the Hon. Mayor Myrna M. Torres and to all concerned for their information, guidance and/or appropriate action.
