RESOLUTION SUPPORTING SENATE BILL NO. 1709 AUTHORED BY SENATOR ROBERT BARBERS WHICH SEEKS TO GANT VICE GOVERNORS AND VICE MAYORS COERCIVE POWERS TO ISSUE SUMMONS, SUBPOENA DUCES TECUM AND TESTIFICANDUM IN THE DISCHARGE OF THEIR LEGISLATIVE FUNCTIONS

WHEREAS, the 1991 Local Government Code seeks to empower the Local Government Units in the discharge of their government functions and adheres to the principles of local autonomy;

WHEREAS, Senate Bill No. 1709 as proposed by Senator Robert Barbers seeks to amend the Local Government Code by specifically granting the Vice Governors and Vice Mayors coercive powers to issue summons and subpoenas;

WHEREAS, this proposed bill will not only empower the local legislatures, but likewise will enable them to effectively discharge their legislative services to their constituents;
