RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. MYRNA M. TORRES IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO SECURE A LOAN FROM LAND BANK OF THE PHILIPPINES IN THE AMOUNT OF TWO MILLION FIFTY THOUSAND PESOS (P2,050,000.00) FOR THE PROCUREMENT OF 2 UNITS VAN/MONITORING VEHICLES AND 1 UNIT ROAD GRADER AND TO SIGN PERTINENT PAPERS AND DOCUMENTS INCIDENTAL THERETO

WHEREAS, the Municipality of Tigbauan is in need of service vehicles (to be used by both Executive and Legislative Departments) and 1 unit road grader, for the effective and efficient delivery of programs and services of the LGU;

WHEREAS, due to budgetary constraints, the LGU-Tigbauan cannot afford to purchase in cash basis said vehicles otherwise it will greatly affect other projects of the municipality;

WHEREAS, pursuant to Art. 100 (a) (2) (iii) of the Rules & Regulations Implementing the Local Government Code of 1991, one of the powers, duties and functions of the Sngguniang Bayan is to authorize the Municipal Mayor to negotiate and contract loans and other forms of indebtedness;

NOW, THEREFORE, on motion of Hon. Ma. Bernardita Taasan, Chairman, Committee on Appropriation, Budget, Finance and Accounts and duly seconded by Hon.. Remedios Torrato,

RESOLVED, to authorize the Municipal Mayor, Hon. Myrna M. Torres in behalf of the Municipality of Tigbauan to secure loan from Land Bank of the Philippines, in the amount of Two Million

Fifty Thousand Pesos (P2,050,000.00) for the procurement of two units van/monitoring vehicles and one unit grader and to sign pertinent papers and documents incidental thereto,

RESOLVED FURTHER, to forward copies of this resolution to Hon. Mayor Myrna M. Torres, for her information and appropriate action, the Land Bank of the Philippines, Iloilo City and to all concerned for their information and guidance.
