RESOLUTION EARNESTLY REQUESTING HON. ROSARIO N. LOPEZ, CHAIRMAN, PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) TO DONATE ONE (1) ADDITIONAL UNIT OF AMBULANCE FOR THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, way back in 1996 the Philippine Charity Sweepstakes had also donated one unit of ambulance for the Rural Health Unit of Tigbauan;

WHEREAS, because of the growing population of the Municipality of Tigbauan totaling at present to 52,000 more or less said m=ambulance could not satisfy and/or cater to the demands for health service of the people, this municipality;

WHEREAS, there is a need for an additional unit of ambulance in order to effectively serve our populace;

WHEREAS, due to budgetary constraints, the LGU-Tigbauan could not afford to purchase the needed additional ambulance unless it can have other sources of funds;

WHEREAS, pursuant to our ordinance, the ambulance shall be used during emergency cases as per assessment by the Municipal Health Physicians and likewise for non-emergnecy cases, such as fetching patients from the hospital back to his/her house and for the private physicians having emergency patients that need to be brought to the hospital;

NOW, THEREFORE, on motion of Hon. Cecilia Garrido, Chairperson, Committee on Health and Sanitation and duly seconded by Hon. Cornelia Teruel,

RESOLVED, to request Hon. Rosario N. Lopez, Chairman, Philippine Chairty Sweepstakes Office (PCSO) to donate one (1) additional unit of ambulance for the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to forward copies of this resolution to PCSO, Chairman, Hon. Rosario N. Lopez, for her favorable consideration, to Hon. Mayor Myrna M. Torres and to all concerned for their information and guidance,
