RESOLUTION REQUESTING THE PENRO, PROVINCE OF ILOILO TO ISSUE ENIRONMENTAL COMPLIANCE
CERTIFICATE (ECC) TO MR. ISIDRO MINERVA TO EXTRACT SAND AND GRAVEL AT THE SIBALOM RIVER AT
BRGY. BAGUMBAYAN, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Art. 100 of the Local Government Code of 1991 (R.A. 7160) empowers the
Sangguniang Bayan to pass a resolution for an efficient protection of the environment;

WHEREAS, the barangay officials of Brgy. Bagumbayan passed a resolution endorsing the said
applicant to quarry in the allowed quarry area at Brgy. Bagumbayan to avoid further river bank
destruction;

WHEREAS, the proper extraction of sand and gravel at the Sibalom River will answer to the
present riverbank destruction and it will also be the source of an additional income to the community;
