RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HONORABLE RONALDO ZAMORA, EXECUTIVE SECRETARY, OFFICE OF THE PRESIDENT, REPUBLIC OF THE PHILIPPINES, IN THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) FOR THE REHABILITATION, REPAIR, AND MAINTENANCE OF DAPDASP-ISAUAN BARANGAY ROAD, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Barangay Dapdap-Isauan Barangay Road, this Municipality was constructed in the early 60's but until now, it is unpassable during rainy season;

WHEREAS, said road is not only serving the residents of Barangays Dapdap and Isauan, but as well as Barangay Isian and other neighboring barangays;

WHEREAS, if this barangay road will be rehabilitated, repaired and maintained, the farm products could be easily transported to the market and this will help uplift the economic status of the farmers;

NOW, THEREFORE, on motion of Hon. George Tribunal, the S.B. Member assigned of the area and duly seconded by Hon. Cecilia Garrido,

RESOLVED, to request financial assistance from Hon. Ronaldo Zamora, Executive Secretary, Office of the President, Republic of the Philippines, in the amount of One Million Pesos (P1,000,000.00) for the rehabilitation, repair and maintenance of Dapdap-Isauan Barangay Road, Municipality of Tigbauan, Province of Iloilo,
