Resolution No. 2000-103

RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HONORABLE RONALDO ZAMORA, EXECUTIVE SECRETARY, OFFICE OF THE PRESIDENT, REPUBLIC OF THE PHILIPPINES, IN THE AMOUNT OF TWO MILLION PESOS (P2,000,000.00) FOR THE REHABILITATION, REPAIR AND MAINTENANCE OF BUYUAN-CANSILAYAN BARANGAY ROAD, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan, comprising of 52 barangays and is 23 kms. away from the City of Iloilo, is one of the fast developing towns in the Province of Iloilo with vast farm lands suited for agriculture and most of its inhabitants are engaged in farming as their means of livelihood;

WHEREAS, residents from the affected barangays are complaining about the bad condition of the Buyu-an-Cansilayan Barangay Road resulting in the difficulty of transporting their farm products to the market specially during rainy season;

WHEREAS, in order to solve this problem, the rehabilitation, repair and maintenance of the said barangay road is badly needed;

NOW, THEREFORE, on motion of Hon. Cornelia Teruel and duly seconded by Hon. Jonathan Torrato,

RESOLVED, to request financial assistance from Hon. Ronaldo Zamora, Executive Secretary, Office of the President, Republic of the Philippines, in the amount of Two Million Pesos (P2,000,000.00) for the rehabilitation, repair and maintenance of Buyuan-Cansilayan Barangay Road, Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to forward a copy of this resolution to Hon. Ronaldo Zomora, Executive Secretary, Office of the President, Republic of the Philippines, 2nd Floor, New Executive Building, Malacanang Palace, Manila for his information and favorable consideration and Hon. Mayor Myrna M. Torres for her information and guidance.
