THOUSAND PESOS (P1,500,000.00) FOR THE CONSTRUCTION OF BAILEY BRIDGE CONNECTING
BARANGAY NO. 2 AND BARANGAY DORONG-AN, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO
