RESOLUTION REQUESTING FINANCIAL ASSSITANCE FROM HON. HORACIO MORALES JR., SECRETARY DEPARTMENT OF AGRARIAN REFORM (DAR), IN THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00) FOR THE CONSTRUCTION OF FARM TO MARKET ROAD FROM SITIO TACUYONG PARARA NORTE, CONNECTING NATIONAL IRRIGATION ADMINISTRATION (NIA) ROAD TO BAILEY BRIDGE AT BARANGAY DORONG-AN, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Sitio Tacuyong, Parara Norte is also one of the beneficiaries of the Agrarian Reform Communities (ARC's);

WHEREAS, there was already the initial construction of the said road but this was not completed because of lack of funds;

WHEREAS, the construction of farm to market road at Sitio Tacuyong, Parara Norte, connecting the NIA Road to the proposed Bailey Bridge at Brgy. Dorong-an will help uplift and improve the economic status of the farmer beneficiaries;

NOW THEREFORE, on motion of Hon. Jonathan Torrato and duly seconded by Hon. Cornelia Teruel and Hon. Cecilia Garrido,

RESOLVED, to request financial assistance from Hon. Horacio Morales, Jr. Secretary Department of agrarian Reform (DAR) in the amount of One Million Five Hundred Thousand Pesos (P1,500,000.00) for the construction of farm to market road from Sitio Tacuyong, Parara Norte, connecting NIA Road to Bailey Bridge at Barangay Dorong-an, Municipality of Tigbauan, Province of Iloilo,
