RESOLUTION REQUESTING HONORABLE FRANKLIN DRILON, SENATE PRESIDENT, REPUBLIC OF THE PHILIPPINES, FOR FUNDING ALLOCATION IN THE AMOUNT OF FIVE HUNDRED TWENTY TWO THOUSAND PESOS (P522,000.00) FOR THE PURCHASE OF ONE (1) UNIT DUPLI 435 DUPLICATING MACHINE AND ONE (1) UNTI MITA DC 1460 PHOTOCOPIER FOR THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan which is about 23 kms. away from the city and has a total population of 52,000 more or less is a fast developing municipality on the Province of Iloilo;

WHEREAS, the Municipal Government of Tigbauan headed by Hon. Mayor Myrna M. Torres had undertaken initial steps to improve the delivery of basic services including the repair and renovation of the Tigbauan Municipal Building, the purchase of various office facilities, (etc. . .) so as to attain effective and efficient public service;

WHEREAS, at present the Municipality is in need of a duplicating and copying machine with a reducer and enlarger that would accommodate the volume of photocopying service of the different office;

WHEREAS, a substantial amount is being spent by the LGU in the photocopying service of the different offices every year;

WHEREAS, due to budgetary constraints, the LGU-Tigbauan has no more available funds to purchase the said needed machine and photocopier thus relying from other sources to fund local projects and services;

NOW, THEREFORE, on motion of Hon. George Tribunal and duly seconded by Hon. Ceciia T. Garrido and Hon. Jonathan Torrato,

RESOLVED, to request Hon. Franklin Drilon, Senate President, Republic of the Philippines for funding allocation in the amount of Five Hundred Twenty Two Thousand Pesos (P522,000.00) for the purchase of one (1) unit Duplo 435 Duplicating Machine and one (1) unit MITA DC 1460 photocopier for the Municipality of Tigbauan, Province of Iloilo

RESOLVED FURTHER, to forward a copy of this resolution to Senate Franklin Drilon, for his information and favorable consideration and to Hon. Mayor Myrna M. Torres for her information and guidance.
