CREATE A SEPARATE MUNICIPAL TRIAL COURT IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan, comprising of 52 barangays has a total population of
52,000 more or less;

WHEREAS, the 15th Municipal Circuit Trial Court (MCTC), serving the municipalities of Tubungan,
Guimbal, Igbaras and Tigbauan with only one judge assigned, holds court (15th MCTC) comes from
Tigbauan, based on the following record:
