RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. MYRNA M. TORRES IN BEHALF OF THE MUNICIPAL GOVERNMENT OF TIGBAUAN, ILOILO TO NEGOTIATE AND/OR ENTER INTO AN AGREEMENT WITH MRS. MANUELA T. BALCUBA (FOR HERSELF & IN BEHALF OF THE HEIRS OF MANUELA TURALDE) FOR THE PURCHASE OF THE PORTION OF LOT NO. 483 CONSISTING OF 224 SQUARE METERS LOCATED AT THE TIGBAUAN PUBLIC MARKET

WHEREAS, the said property has a total land area of 987 square meters;

WHEREAS, a portion of the said property with an area of about 763 square meters (more or less) is presently occupied by the Tigbauan Public Market;

WHEREAS, the owner of the property has signified her intention to donate said portion/area (763 sq. m) in favor of the Municipal Government, provided that the Municipality shall purchase the remaining area of 224 square meters with a purchase price of at least P241,920.00 based on its current market/assessed value;

WHEREAS, considering that the offered purchase price of the said property is very minimal, this would be advantageous to the Municipal Government and would benefit specially the entire populace;

NOW, THEREFORE, on motion of Hon. Richard Tenerife, chairman, committee on environmental Protection, Housing, land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Rene Ledesma and Hon. Remedios Torrato,

RESOLVED, to authorize the Municipal Mayor Myrna M. Torres in behalf of the Municipal Government of Tigbauan, Iloilo to negotiate and/or enter into an agreement with Mrs. Manuela T.

Balcuba ( for herself and in behalf of the heirs of Manuela Turalde) for the purchase of the portion of Lot No. 483 consisting of 224 square meters located at the Tigbauan Public Market,

RESOLVED FURTHER, to forward a copy of this resolution to Hon. Mayor Myrna M. Torres for her information and appropriate action to Mrs., Balcuba for her information and guidance.
