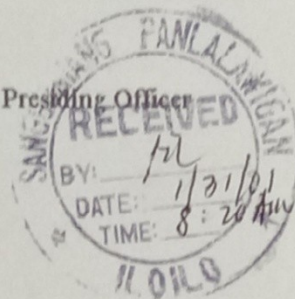

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A  
MEMORANDUM OF AGREEMENT BETWEEN THE MUNICIPALITY OF TIGBAUAN,  
ILOILO AND DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD),  
REGION VI, ILOILO CITY TO IMPLEMENT THE COMPREHENSIVE AND INTEGRATED  
DELIVERY OF SOCIAL SERVICES (CIDSS) PROGRAM

WHEREAS, Section 3 of Executive Order 442 directs all Local Government Units for the  
adoption and implementation of CIDSS in coordination with DSWD;

WHEREAS, CIDSS directly aimed to alleviate poverty and focus on building capabilities  
of the poor to meet their minimum basic needs with the involvement of the community members;

WHEREAS, Tigbauban being a 4<sup>th</sup> class municipality and as a recipient, will assume the full  
responsibility with regard to the implementation, supervision, monitoring, evaluation and  
maintenance of the said program which will be piloted by 2 (two) barangays;

WHEREAS, the Local Government of Tigbauban will initiate concrete steps to prepare for  
the eventual absorption and replication of the project in the other barangays of the municipality;

WHEREAS, after due deliberation by the Joint Committees on Health and Social Welfare,  
recommendation for its implementation and authorization to the Municipal Mayor had been  
forwarded;

NOW, THEREFORE, on motion of Hon. Cornelia T. Teruel, Chairman, Committee on  
Education and Culture, Tourism, History, Manpower Development and Civil Service and  
Committee on Social Services and duly seconded by Hon. Richard Tenerife,

RESOLVED, to authorize the Municipal Mayor to enter into a Memorandum of  
Agreement between the Municipality of Tigbauban, Iloilo and the DSWD, Region VI, Iloilo City to  
implement the Comprehensive and Integrated Delivery of Social Services (CIDSS) Program,




