RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE MAYOR MYRNA M. TORRES TO NEGOTIATE AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH MR. HIROYUKI TSUCHIYA OF R.H. INTERNATIONAL CO., LTD., OF YOKUSUKA KANAGAWA-KEN, JAPAN IN CONNECTION WITH THE DONATION OF ONE (1) UNIT OF 6-WHEELER FIRE TRUCK WITH 200 LITERS CAPACITY AND ONE (1) UNIT OF POLICE PATROL CAR FOR THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, firefighting equipment is very essential in maintaining public service and safety in saving life and property of our constituents;

WHEREAS, a police patrol car is necessary for the maintenance of peace and order, police visibility and other related matters such as the conduct of a roving check point in the municipality;

International Co., Ltd., of Yokusuka Kanagawa-Ken, Japan in connection with the donation of One (1) unit of 6-wheeler fire Truck with 2000 liters capacity and one (1) unit of police patrol car for the Municipality of Tigbauan, Province of Iloilo,
