RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HONROBALE SENATOR LOREN LEGARDA LEVISTE IN THE MAOUNT OF THREE MILLION PESOS (P3,000,000.00) FOR THE IMPROVEMENT OF TIGBAUAN MUNICIPAL BUILDING AND THE CONSTRUCTION OF THE SOCIAL HALL, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Tigbauan Municipal Building was constructed wayback in the early 60's and some of its portions are already very dilapidated by use and age;

WHEREAS, for the interest of an efficient and effective public service and for the safety of our people, the officials of this Municipality down their hopes to be good senator for the improvement

and/or renovation of the Tigbauan Municipal Building and the construction of the Social Multi-Purpose Hall shall be named as Loren Legarda Hall;
