RESOLTUION REQUESTIN THE DENR, REGION VI, ILOILO CITY TO ISSUE ENVIRONMENTAL COMPLIANCE CERTIFICATES (ECC) TO MR. FELOMINO TAYONGTONG AND MISS FELICITAS TRENTADO TO EXTRACT SAND AND GRAVEL AT THE SIBALOM RIVER WITHIN THE TERRITORIAL JURISDICTIONOF BOTH BARANGAYS BAROSONG AND CORDOVA NORTE, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Art. 100 of the Local Government Code of 1991 (R.A. 7160) empowers the Sangguniang Bayan to pass a resolution for an efficient protection of the environment;

WHEREAS, the barangay officials of Barangays Barosong and Cordova Norte passed a joint resolution endorsing the said applicants to quarry in the allowed quarry area at Barangays Barosong and Cordova Norte to avoid further riverbank destruction;

WHEREAS, the proper extraction of sand and gravel at the Sibalom river will answer to the present riverbank destruction and it will also be the source of an additional into to the community;

NOW, THEREFORE, on motion of Hon. Cornelia T. Teruel Vice Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. George T. Tribunal,

RESOLVED, to request the DENR, Region VI to issue Environmental Compliance Certificates (ECC) to Mr. Felomino Tayongtong and Mrs. Felicitas Trentado to extract sand and gravel at the Sibalom River within the territorial jurisdiction of both Barangays Barosong and Cordova Norte, Municipality of Tigbauan, Province of Iloilo;

RESOLVED FURTHER, to forward copies of this resolution to the Governor, province of Iloilo, DENR, Region VI, to Hon. Mayor Myrna M. Torres and to all concerned for their information, guidance and/or appropriate action.
