RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM EXECUTIVE SECRETARY RENATO S. DE VILLA, CHAIRMAN, OVERSIGHT COMMITTEE ON DEVOLUTION, OFFICE OF THE EXECUTIVE SECRETARY, MABINI HALL, MALACANANG PALACE, MANILA, IN THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) FOR THE IMPROVEMENT OF BARANGAY CANSILAYAN-BUGASONGAN ROAD, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Barangay Cansilayan-Bugasongan Road, a farm to market road, stretches about .525 kilometers and connects the Barangays of Cansilayan and Bugasongan, Municipality of Tigbauan, Iloilo;

WHEREAS, the said road is considered as the route of agricultural products and other industries produced by the farmers situated in the area and marketed in the Municipalities of Tigbauan, Leon, Alimodian, San Miguel, the city of Iloilo and other adjacent municipalities in the province;

WHEREAS, due to financial constraints the municipality has no available funds for the improvement of said road;

WHEREAS, because of the prevailing unfavorable road condition and high cost of transportation, the government suffers much of the losses, hence, the delivery of the basic government services to the said community is greatly hampered/affected;

NOW, THEREFORE, on motion of Hon. George T. Trbunal and was duly seconded unanimously;

RESOLVED, to request Executive Secretary Renato S. De Villa, in the amount of One Million Pesos (P1,000,000.00) for the improvement of Barangay Cansilyan-Bugasongan market road, Municipality of Tigbauan, Province of Iloilo

RESOLVED FURTHER, to furnish a copy of this resolution to Executive Secretary Renato S. De Villa, for his information and favorable action.
