### Resolution No. 2001-036

RESOLUTION AUTHORZING THE MUNNICIPAL MAYOR OF TIGBAUAN, ILOILO TO TRANSACT/NEGOTIATE AND SIGN A CONTRACT WITH THE HOME GUARANTY CORPORATION, PANAY FIELD OFFICE, DOOR 2, JARO COMMERCIAL COMPLEX, STA. ISABEL STREET, JARO, ILOILO CITY

WHEREAS, by the virtue of the BLISS Housing Project of the Ministry of Human Settlements, the Tigbauan Bagong Lipunan Community Association was sometime in 1980, duly organized and subsequently issue a Certificate of Incorporation by the said Ministry;

WHEREAS, after having been duly incorporated, the said association was granted by the aforesaid ministry, thru the National electrification Administration (NEA), a housing loan in the amount of ONE MILLIO N PESOS (P1,000,000.00);

WHEREAS, the above said loan having been granted, the construction of the said housing project was started sometime in November, 1980 and which project was handled/contracted by the R T MANZANO CONSTRUCTION;

WHEREAS, the housing units in the said project having been finished and completed the same were distributed to the Officers and Members of the above-said association;

WHEREAS, the Officers and Members of the Tigbauan Bagong Lipunan Community Association received and accepted to their entire and full satisfaction their respective finished and

complete housing units from MR. ROMEO MANZANO thru a DEED OF ACCEPTANCE executed on the 24<sup>th</sup> day of January 1981;

WHEREAS, the beneficiaries (totaling fifty) of the housing project occupied their respective housing units last May 1982 with the obligation to pay the monthly amortization for the said housing units;

WHEREAS, the BLISS Housing Project under the supervision of the Ministry of Human Settlements stopped collecting payments from the fifty (50) occupants and requested the municipality to collect in behalf of the abovementioned ministry;

WHEREAS, Home Guaranty Corporation, a government-owned and controlled corporations now owns the Rural BLISS I Project by virtue of a Presidential Memorandum dated May 1988;

WHEREAS, in view of this, Home Guaranty Corporation is offering for sale the Rural BLISS I project to the Municipal Government of Tigbauan, Iloilo;

NOW, THEREFORE, on motion of Hon. Richard Tenerife, Chairman on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. George Tribunal,

RESOLVED, to Authorize the Municipal Mayor of Tigbauan, Iloilo to Transact/Negotaiate and Sign a Contract With the Home Guaranty Corporation, Panay Field Office, Door 2, Jaro Commercial Complex, Sta. Isabel Street, Jaro, Iloilo City,

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Mayor Myrna M. Torres and Home Guaranty Corporation, thru Ma. Socorro Cecilia S. Salmon, for their information, guidance and/or appropriate action.
