RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO EXECUTE FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF TIGBAUAN, ILOILO A DEED OF DONATION OF A FIRE TRUCK IN FAVOR OF THE BUREAU OF FIRE PROTECTION, REGION VI, ILOILO CITY

WHEREAS, the LGU, Tigbauan with business and postal address at Tigbauan, Iloilo, represented herein by its Municipal Mayor, Myrna M. Torres, a Filipino National, of legal age and with residence and postal address at Barangay Tan Pael, Tigbauan, Iloilo, hereafter referred to as the DONOR is a local government unit and the absolute owner of one (1) Unit Fire Truck;

WHEREAS, the Bureau of Fire Protection represented by its Regional Director Supt. Santiago R. Laguna, hereinafter referred to as the DONEE is one of the National Government Agencies in the Province of Iloilo, tasked to prevent from fire damages properties and lives of the citizenry and other projects beneficial to the citizenry of the municipality;

WHEREAS, by virtue of the zeal shown by the DONEE's enthusiasm in making the municipality progressive and a better place to live in and tremendous affection and goodwill generated by it toward DONOR, the latter, compelled by the aspect of helping the DONEE in promoting the general welfare of the inhabitants and to prevent from fire damages properties and lives of the citizenry hereby donates to the DONEE the aforesaid vehicle;

WHEREAS, the DONEE expresses great thanks unto the DONOR for the latter's generosity and liberality;

WHEREAS, the DONEE shall provide the salary wages and other benefits of the personnel assigned in the Municipality of Tigbauan;

WHEREAS, the DONEE shall assume any and all expenses incident to the repair and maintenance of the above-mentioned vehicle;

WHEREAS, the donation shall be non-revocable and without any condition except those contained in the Deed of Donation;

NOW, THEREFORE, on motion of Honorable Rexfel G. Trivilegio and duly seconded by Hon. Remedios T. Torrato and Hon. George T. Tribunal,

RESOLVED, to authorize the Municipal Mayor to execute for and in behalf of the Municipal Government of Tigbauan, Iloilo a Deed of Donation of a Fire Truck in favor of the Bureau of Fire Protection Region VI, Iloilo City,

RESOLVED FURTHER, to forward copies of this Resolution to the Bureau of Fire Protection, Region VI, Iloilo City and to Hon. Mayor Myrna M. Torres for their information and appropriate action.
