RESOLUTION REQUESTING THE PENRO, PROVINC OF ILOILO TO ISSUE PERMIT TO MR. ERNESTO TUVIDA TO EXTRACT SAND AND GRAVEL AT THE SIBALOM RIVER AT BARANGAY NAPNAPAN NORTE, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Art. 100 of the Local Government Code of 1991 (R.A.7160) empowers the Sangguniang Bayan to make measures for an efficient protection of the environment;

WHEREAS, the Barangay Officials of Barangay Napnapan passed a resolution endorsing the said applicant to quarry in the allowed quarry area at Brgy. Napnapan to avoid further riverbank destruction;

WHEREAS, the proper extraction of sand and gravel at the Sibalom River will answer to the present riverbank destruction and it will also be the source of an additional income to the community;

NOW, THEREFORE, on motion of Hon. Ricahrd Tenerife, Chairman, Committee on Environmental protection, housing, Land and Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Remedios Torrato,

RESOLVED, to request the PENRO, Province of Iloilo to issue Permit to Mr. Ernesto Tuvida to extract sand and gravel at the Sibalom River at Brgy. Napnapan Norte, Municipality of Tigbauan, Province of Iloilo;

RESOLVED FURTHER, to forward copies of this resolution to the PENRO, Iloilo City, Governor, Province of Iloilo, to Hon. Mayor Myrna M. Torres and to all concerned for their information, guidance and/or appropriate action.
