WHEREAS, the Sanggunian Bayan in a session assembled, approved the 3 Resolutions of Deep Appreciation and Recognition for the Invaluable Services Rendered by Honorable CORNELIA T. TERUEL, Honorable RICAHRD T. TENERIFE and Honorable RENE T. LEDESMA as an Outstanding Members of the Sangguniang Bayan of the Municipality of Tigbauan, Province of Iloilo from the Years 1992-2001, 1998-2001 and 1992-2001, respectively;

WHEREAS, said resolutions shall be given to them during the expiration of their term of office;
