RESOLUTION REALIGNING THE BANTAY DAGAT AVAILABLE BALANCE OF FIFTY FOUR THOUSAND PESOS (P54,000.00) FROM THE 20% IRA FUND 2000 FOR THE HONORARIUM OF THE SEVEN (7) PERSONNEL AND TWO (2) VOLUNTEERS OF THE BUREAU OF FIRE PROTECTION ASSIGNED IN THE MUNICIPALITY OF TIGBAUAN IN THE AMOUNT OF ONE THOUSAND PESOS (P1,000.00) EACH FROM JULY 2001 TO DECEMBER 2001

WHEREAS, the Bureau of Fire Protection has assigned 7 personnel and 2 volunteers in the Municipal Government of Tigbauan, Iloilo to manage the Fire Truck procured by the municipality;

WHEREAS, these 7 regular personnel and two volunteers, work on 24 hour shiftment basis;

WHEREAS, the provision on the Honorarium seeks to augment their salary and other miscellaneous expenses while performing their duties;

NOW, THEREFORE, on motion of Hon. George T. Tribunal Chairman, Committee on Appropriation, Budget, Finance and Accounts and duly seconded by Hon. Rexfel G. Trivilegio,

RESOLVED AS IT IS HEREBU RESOLVE, to realign the Bantay Dagat available balance of Fifty Four Thousand Pesos (P54,000.00) from the 20% IRA Fund 2000 for the Honorarium of the seven (7) personnel and two (2) volunteers of the Bureau of Fire Protection assigned in the Municipality of Tigbauan in the amount of One Thousand Pesos (p1,000.00) each from July 2001 to December 2001,

RESOLVED FURTHER, to furnish copies of this resolution to Hon. Mayor Myrna M. Torres, to the Municipal Accountant, Municipal Treasurer, Municipal Budget Officer and to all concerned for their information, guidance and/or appropriate action.
