RESOLUTION TRANSFERRING THE BUST STATUE OF FORMER PHILIPPINE PRESIDENT RAMON MAGSAYSAY FROM ALLERA AND TEJERO STREETS, TIGBAUAN, ILOILO TO BE PLACED INSIDE THE MUNICIPAL BUILDING

WHEREAS, the bust statue of former Philippine President Ramon Magsaysay was strategically placed in the junction of Allera and Tejero Streets;

WHEREAS, the location is considered as the busiest street in the Poblacion as it is located at the heart of the Tigbauan commercial center;

WHEREAS, the municipal government planned to construct a Police Assistance Center in place of the bust statue of former Philippine President Ramon Magsaysay as a deterrence of crime and other human atrocities;
