RESOLUTION REQUESTING THE MANAGEMENT OF THE ILOILO ELECTRIC COOPERATIVE 9 (ILECO I), TIGBAUAN, ILOILO TO REPRAIN FROM CUTTING AND TRIMMING TREES ALONG THE NATIONAL, PROVINCIAL, MUNICIPAL AND BARANGAY ROADS WITHIN THE JURIDSCITION OF THE MUNICIPALITY OF TIGBAUAN WITHOUT PROPER COORDINATION AND CONSULTATION FROM THE MUNICIPAL GOVERNMENT

WHEREAS, the Municipal Government in its request for “Matahum kag Mainuswagon nga Tigbauan” has an on-going clean and green program along the National, Provincial, Municipal and Barangay roads in the Municipality of Tigbauan;

WHEREAS, it has been noted that the Iloilo Electric Cooperative (ILECO-I) was unjustly cutting and trimming fully grown trees along the highways and the interior roads of the Municipality which affects the electric lines of ILECO 1;

WHEREAS, the unjust trimming and cutting of trees without consultation and coordination from the Municipal Government undermined the beautification program of the Municipality;

NOW, THEREFORE, on motion of Hon. Rexfel G. Trivileio, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonitification, Assessment and Expropriation and duly seconded by Hon. Cecilia Garrido,

RESOLVED AS IT IS HEREBY RESOLVED, to pass this resolution requesting the management of the Iloilo Electric Cooperative (ILECO I) to refrain from trimming and cutting fully grown trees along the National, Provincial, Municipal and Barangay roads of the Municipality of Tigbauan without proper coordination and consultation from the Municipal Government,

RESOLVED FURTHER, to furnish copies of this resolution to the management of the ILECO I, Tigbauan, Iloilo, All Punong Barangays in the Municipality and other concerned agencies and institutions for their information and proper guidance
