RESOLUTION REQUESTING THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE, MANILA, PHILIPPINES TO GRANT THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) FOR THE PURCHASE OF MEDICINES FOR THE USE OF (52) BARANGAYS OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Fifty Two (52) barangays of the Municipality of Tigbauan, Province of Iloilo is in dire need of medicines;

WHEREAS, the whole Municipality at this moment of time is being affected by the dengue fever, an infectious tropical fever caused by the mosquitoes;

WHEREAS, aside from the dengue fever affecting the Fifty Two (52) barangays, malnutrition is also rampant in the whole Municipality;

NOW, THEREFORE, on motion of Hon. Ramonita Alcala, Chairperson, Committee on Barangay Affairs and duly seconded by Hon. Romeo Ledesma and Hon. Agaton Tumabotabo,

RESOLVED AS IT IS HEREBY RESOLVED, to request the Philippine Charity Sweepstakes Office, Manila, Philippines to grant the amount of One Million Pesos (P1,000,000.00) as aid for the purchase of medicines for the use of fifty two (52) barangays of the Municipality of Tigbauan, Iloilo,
