WHEREAS, the construction of the Tigbauan Waterworks System project in the Municipality of Tigbauan will provide the municipality with adequate, safe and potable water supply;

WHEREAS, the Tigbauan Waterworks System project shall be undertaken by the Municipality through a loan package from the Japan Bank of International Cooperation or other financing institutions;
