RESOLUTION REQUESTING HON. SERGIO OSMENA III, SENATOR OF THE REPUBLIC, TO ALLOCATE THREE MILLION PESOS (P3,000,000.0) FOR THE CONSTRUCTION OF A NEW 2-STOREY MARKET BUILDING INCLUDING ITS AMENITIES AND/OR FACILITIES, IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan, 22.85 kms. south of Iloilo City, has 52 barangays and has a total population of 51,368 with 25,357 registered voters as of May 14, 2001;

WHEREAS, the existing market structures, many of which were built sometime in the 1920's are in the state of dis-repair and dilapidation;

WHEREAS, the municipal government of Tigbauan is planning to relocate the Market outside the Poblacion to ease the traffic congestion and where there is ample space for parking purposes;

WHEREAS, with the growth of population there is a need to improve market facilities to answer the needs of an expanding population;

WHEREAS, with the establishment of SEAFDEC-AQD at Brgy. Buyu-an, Municipality of Tigbauan, there are many Asian nationals residing in Tigbauan, who have tremendous consumption of consumer goods, such as food, fish, fruits, etc.;

WHEREAS, with the construction of this marketing outlet, there will be a quantum leap in the development of the Municipality of Tigbauan in particular and a multiplier effect in the development of the Province of Iloilo in general;

NOW, THEREFORE, on motion of Hon. Rexfel G. Trivilegio and upon the sponsorship of Romeo T. Ledesma, Chairman, Committee on Tourism, History, Cultural Affairs and Manpower Development and duly seconded by Hon. Agaton Tumabotabo and Hon. Alfonsito,

RESOLVED, to request Hon. Sergio Osmena III, Senator of the Republic to allocate Three Million Pesos (P3,000,000.00) for the construction of 2-Storey Market building including its Amenities and/or facilities in the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to forward the original copy of this Resolution to Hon. Senator Sergio Osmena III, for his attention to and favorable action on this request,

RESOLVED FINALLY, to provide a copy of this Resolution to the Association of Barangay Captains for their information.
