RESOLUTION REVITALIZING THE ASSIGNMENT OF SB MEMBERS AS “SB’S OF THE DAY” FOR EVERY WORKING DAY OF THE WEEK, BY THE SANGGUNIANG BAYAN OF TIGBAUAN, ILOILO FOR A MORE EFFECTIVE AND IMMEDIATE DELIVERY OF BASIC SERVICES TO OUR PEOPLE

WHEREAS, within the purview of the Local GOVERNMENT Code of 1991, and concomitant to its declaration of policy, the SB as a structure of local government should be “ more responsive and accountable” to the people who we serve;

WHEREAS, our people from far-flung barangays who have some business with the SB are often at a loss whom to approach for assistance and or attention;

WHEREAS, aside from attending sessions, we have sworn an oath to serve our people according to the best of our humble ability and conscience;

WHEREAS, the institution of SB Members as “SB’S OF THE DAY” is a multi-lateral form of “operating mechanism” that will help in meeting the priority needs and services requirements of our municipality;

WHEREAS, at least two (2) SB members shall be on duty or “SB’s OF THE DAY” for every working day off the week, their names to be posted at the SB session hall at the municipal building by the Secretariat;

WHEREAS, the Sangguniang Bayan members consensually agreed to adopt the following schedule of SB’S OF THE DAY” which shall take effect on September 3, 2001:
