RESOLUTION ADOPTING AND SUPPORTING THE NATIONAL VOLUNTARY BLOOD SERVICES PROGRAM

WHEREAS, the National Voluntary Blood Services Program, as mandated by Republic Act No. 7719 or the “National Blood Services Act of 1991”, will ensure adequate and safe supply of human blood to meet the needs for blood transfusion;

WHEREAS, there is a need and responsibility to promote and encourage voluntary blood donation by the citizenry and instill public consciousness of the principle that donation is a humanitarian act and a social responsibility;

WHEREAS, a local organization for the program through an Executive Order is deemed necessary for program development and management which includes among others, the planning and coordination of core activities such as promotion of voluntary blood donation, recruitment, retention and paper documentation of voluntary blood donors;

WHEREAS, in order to attain and sustain adequacy of blood supply, every year the municipality shall recruit 520 blood donor or at least 1% of the total population between 16-65 years

of age, male or female who are physically fit and whose qualifications as blood donors shall be determined by a paramedical and medical team;

WHEREAS, the municipality will hold its regular Mass Blood Donation activities to involve all barangays and sectors of the society every April and October of the year and every year thereafter;

WHEREAS, it is likewise necessary to establish walking Blood Donors Registry per barangay through Mass Blood Typing activities involving 15-65 years old male and female populace and the registry shall be properly documented, kept and updated o serve its purpose;

WHEREAS, the municipality shall provide budgetary allocation in the amount of P70,000.00 for the succeeding year but may vary every year thereafter chargeable against the funds of Social Services to be utilized for activities and logistical needs of the program with proper work and financial planning;

WHEREAS, the National Voluntary Blood Services Program shall be integrated as a regular program in the Municipal Development Plan every year;

NOW, THEREFORE, on motion of Hon. Cecilia T. Garrido, Chairman, Committee on Health and Sanitation and duly seconded by Hon. Romeo Ledesma,

BE IT RESOLVED AS IT IS HEREBY RESOLVE by the Sangguniang Bayan of the Municipality of Tigbauan, Province of Iloilo to adopt the National Voluntary Blood Service Program,

REOLVED FURTHER, that copies of this resolution be furnished the Sangguniang Panlalawigan of Iloilo, Iloilo Provincial Health Office, DOH-Center for Health Development for Region 6 (formerly DOH Regional Field Office No. 6) Western Visayas Medical Center Blood Bank Section and the Western Visayas Regional Blood Center (PNRC Blood Bank) and Red Cross, Iloilo City
