RESOLUTION ENDORSING THE VARIOUS INFRASTRUCTURE PROJECTS IN THE AMOUNT OF FIFTY FIVE MILLION PESOS (P55M) TO HON. ALBERTO V. ROMULO, EXECUTIVE SECRETARY AND CHAIRMAN, OVERSIGHT COMMITTEE ON DEVOLUTION (OCD) THROUGH ATTY. RENE E. PUNO, HEAD OCD SECRETARY, FOR FUNDING SUPPORT UNDER THE LOCAL GOVERNMENT SERVICE EQUALIZATION FUND (LGSEF)

WHEREAS, R.A. 7160 otherwise known as the Local Government Code of 1991 delegated specific functions and responsibilities to Local Government Units particularly on the effective and efficient delivery of basic services and facilities at the local level;

WHEREAS, there is an urgent need to provide fund assistance to LGUs in order to alleviate their financial burdens in carrying out the devolved functions and responsibilities, as specified by the Code;

WHEREAS, Executive Order No. 48, series of 1998, established a Program for Devolution Adjustment and Equalization Fund, renamed as Local Government Service Equalization Fund (LGSEF) which is primarily aimed at enhancing the capacities of LGUs to fully and effectively exercise their devolved functions, services and facilities;

WHEREAS, the Municipality of Tigbauan desires to implement its various Infrastructure Projects congruent with the socio-economic and Development agenda of the Arroyo Administration;

WHEREAS, the Municipal Government of Tigbauan lacks the financial apacity to implkement the aforementioned projects;

NOW, THEREFORE, on motion of Hon. Cecilia T. Garrido, Chairman, Committee on Women, Family and Human Rights and duly seconded by Hon. Remedies T. Torrato and Hon. Romeo T. Ledesma,

RESOLVED, as it hereby resolved, to indorse the various Infrastructure Projects in the amount of Fifty Five Million Pesos (P55M) to Hon. Alberto V. Romulo, Executive Secretary and Chairman, Oversight Committee on Devolution (OCD) through Atty. Rene E. Puno, Head OCD Secretary, for funding support under the Local Government Service Equalization Fund (LGSEF)
